1. 30-Day Rule is in effect. Qualifiers are 10:00 AM Friday; declare by 9:00 am Thursday.
PACE – 2:01; 3YO – 2:02; 2YO – 2:05 TROT – 2:04; 3YO – 2:05; 2YO – 2:08
2. In condition events, horses may not drop more than 2 classes per start unless approved by the Race Secretary.
3. Events will be combined if necessary to put together a complete race card.
4. It is the trainer's responsibility to denote an alternate event and whether their horse is a Florida-Bred.
5. Horses entered in the incorrect condition class will be transferred to the class to which they are eligible. Those horses will lose their preference date and be placed at the back of the line. Horses, which are transferred because their event did not fill, will not lose their preference date.
6. Horses eligible to lower condition events that are entered in higher condition events may be declared non-competitive and left out of the draw. Maidens, NW 1 PM and horses showing (last 8 lines) \$4,000 claiming class or less are not eligible to condition events.
7. **CLAIMING RULE:** Any horse claimed at Pompano Park cannot race at another track for 60 days or the end of the meet – NO EXCEPTIONS.
8. A horse scratching from postposition 8 or 9 will receive the same post position if the horse is re-entered in any event within seven (7) days not counting the race day from which the horse is scratched.
9. If an event does not fill and is needed to complete the race card, an in-to-go horse, including horses entered in claiming events, may be used to fill that event.
10. A trainer with an entry in an event, coupled or uncoupled, will only be allowed one entry per division of that event unless that event does not fill. No trainer may have more than 2 entrants in an event.
11. Florida-Breds Allowed 10% on condition earnings, per start earnings and any capped earnings.
